SUMMARY OF ACTIONS

The following SUMMARY is a brief description of the actions taken by the 2011 Summer Huntsville Presbytery of the Cumberland Presbyterian Church in America, July 12-16, 2011. This SUMMARY is not intended to be nor is it, the authoritative document for guiding the Presbytery's actions. The intent is to summarize the work of the Huntsville Presbytery. 9. **AFFIRMED** the 2012 meeting of the Huntsville Presbytery to convene in Huntsville, Alabama with the Blackburn Chapel CPCA to serve as host.

14. **ADOPTED THE BOARD OF BUDGET AND FINANCE REPORT.**

15. **ADOPTED THE COMMITTEE ON MINISTRY REPORT and COMMENDED** the Reverend Endia Scruggs for her outstanding leadership as chair of the Committee on Ministry.

The Committee on Ministry **URGED** the Huntsville Presbytery to continue working on enforcing and encourage all members of the Huntsville Presbytery to be more accountable, in order to reduce absenteeism at the Annual Presbytery.

The COM **RECOMMENDED** the above-named persons to the Huntsville Presbytery for acceptance and approval of their status as Probationers, this July 2011.

16. **ADOPTED THE BOARD OF JUDICIARY REPORT**

REFERRED the General Assembly's definition of active and inactive members and the role of the church session back to the Board of Judiciary.

17. **ADOPTED THE REPORT OF THE 2011 COMMISSIONERS TO THE GENERAL ASSEMBLY**

18. **ADOPTED THE EXECUTIVE REVIEW REPORT**

CONCURRED that the Huntsville Presbytery appoint a HP Disaster Relief and Recovery Team that is constituted by the designated positions of (a) Chairperson of HP Board of Missions and Evangelism, (b) President of the HP Missionary Society, and (c) Advisor of the HP CPYF.

CONCURRED that the HP DRRT designs a plan of training and response that will be presented to the HPEB for approval and for implementation (subject to final approval by the HP).

CONCURRED that the Huntsville Presbytery continue to keep first things first, as we help to equip clergy, officers and laity of the HP congregations to focus upon faithfully fulfilling the biblical mandates of The Great Commission of reaching the unchurched and teaching those who will avail themselves of the opportunities.

CONCURRED that the Huntsville Presbytery continues to financially support the www.huntsvillepresbytery.org website communication ministry.

CONCURRED that the Huntsville Presbytery continues to seek ways to increase the effective communication and cooperation between Pastors and Elders who comprise the Church Session as well as between the Church Session and congregation.

CONCURRED that Moderator Mitchell Walker be given words of appreciation for encouraging the Huntsville Presbytery to provide disaster relief to those affected by the storm.

CONCURRED that the Huntsville Presbytery hosts the General Assembly in 2014.

CONCURRED that Chelsea CPCA, New Heaven CPCA and Triana CPCA be requested to pay their Tithes/Offerings at the 2011 Summer Presbytery, or within 30 days after the close of the 2011 Summer Presbytery. Chelsea CPCA request in regards to being unable to send its financial share in this session of the Huntsville Presbytery was granted. New Heaven CPCA paid their Tithes/Offerings on Tuesday, July 12, 2011.

CONCURRED that Chelsea CPCA and Mt. Sinai CPCA be requested to submit their Congregational Report at the 2011 Summer Presbytery, or within 30 days after the close of the 2011 Summer Presbytery.

19. ADOPTED THE MISSION AND EVANGELISM, MISSIONARY SOCIETY, JR. MISSIONARY SOCIETY REPORT

APPROVED the contribution of \$1000.00 to Annie Beasley and Rick & Ollie Carter of the Harvest Community from the Disaster Relief Fund.

20. ADOPTED THE HUNTSVILLE PRESBYTERY SUNDAY SCHOOL CONVENTION AND CPYF REPORT

21. **THE SELECT COMMITTEE ON HISTORY REPORT** observed from the report of the Committee on History that the Committee is non-functional and **RECOMMENDS** that the HPEB take immediate over site of the committee to give them guidance so they can accomplish their tasks as set forth by our Constitution.

22. ADOPTED THE AUDIT OF THE FINANCIAL RECORDS REPORT

CONCURRED with the BOB&F's recommendation to request of the Alabama Synod that all Presbyteries not be required to pay the 10% taxation to the Alabama Synod this year-2011.

23. ADOPTED THE COMMITTEE ON COMMUNICATIONS REPORT

24. ADOPTED THE COMMITTEE ON STATISTICS REPORT

The Body **CONSENTED** that 30 September will be the deadline date for the requested information on the Report of Congregation from Church Street CPCA, Madkins Chapel CPCA, and Union Hill CPCA that was not reported.

25. ADOPTED THE CHRISTIAN EDUCATION REPORT

CONCURRED that the By-Laws Committee reviews the By-Laws to ensure no overlay of training requirements between Committee on Ministry and the BOCE.

CONCURRED that the Presbytery requires all auxiliaries to coordinate training requirements with the BOCE and whenever possible, support group auxiliary training.

26. ADOPTED THE COMMITTEE ON CHURCH SESSION RECORD BOOKS #1 REPORT
